Subject: Hyderabad SHE Teams Crackdown on Indecent Behaviour in Public Spaces

Hyderabad SHE Teams, based on a complaint received from public She teams have taken significant action against individuals engaged in indecent behaviour in public places. Recent incidents have highlighted the growing concern over the disregard for public decency and the creation of nuisance in public spaces by some couples who are engaged in indecent activities.

In a proactive move, Hyderabad SHE Teams conducted operations resulting in the apprehension and subsequent legal action against individuals involved in indecent behaviour including women. Video evidence collected by SHE Teams has been instrumental in the identification and prosecution of offenders.

As a consequence of these operations, a total of **12** individuals have been convicted under Section **70 (b) of the CP Act**, with each facing a fine of Rs- **50/-** for their inappropriate conduct. Additionally, **2** individuals have been convicted with **70(B) 290IPC 188 CP act** with a fine of Rs-**1250/-** each for their aggravated offense.

ARREST OF ACCUSED SRINATH RATHI WHO CHEATED MANY CHARTED ACCOUNTANTS (VICTIMS) AND COLLECTED HUGE AMOUNTS TO THE TUNE OF RS. 2.48 CRORES

On credible information on 22-02-2024 apprehended the accused/cheater Srinath Rathi S/o Purushotham Rathi aged 29 years, occ: Teaching R/o HNo. 3-1-319, Flat No. 202, Sri Krishna apartments, Nimboliadda, Kachiguda, Hyderabad as he is involved in Cr.No.59/2024 U/s. 420 IPC of CCS, DD, Hyd. The accused targets many chartered accountants (victims) the accused collected huge amount from many chartered accountants around Rs.2.48 Crores.. Initially the accused supposed to repay their amounts, but after crediting amounts to accounts given by the accused, he started to avoid the victims contacts and phone calls with an intention of evading their amounts and cheated them.

Modus Operandi:

The accused with false promises attracts the victims, on believing accused words the victims paid huge amounts, after crediting amount into accused accounts, he avoids victims.

The investigation officer Sri. D. Bikshapathi, Inspector of Police, along with staff HC Srisailam and PC Naresh Babu, nabbed the accused Srinath Rathi under the supervision of Sri. G. Venkateshwara Reddy, ACP, EOW team-XI, and produced the accused before the Hon`ble XII ACMM Court for judicial Remand.
