**DETECTED MYSTERIOUS MURDER CASE - ONE HELD**

On credible information the sleuth's of Commissioner's Task Force Central Zone team apprehended one accused Chepuri Narender, aged about 41 yrs N/o. Suryapet R/o. Baghlingampally and detected mysterious murder case of Chikkadapally PS vide Cr.No.107/2024 U/s 302 IPC. reported on 17-03-2024.

➤ **Details of apprehended accused :**

Chepuri Narender S/o. late CH.Venkateswarlu (Late), age. 41 yrs, Occ. Catering work R/o: Footpath, Baghlingampally, N/o. Suryapet, Telangana

➤ **Details of deceased:-**

Shastry Gopal Reddy, S/o Shastry laxminarayana, aged about 72 years, R/o: Hyderabad

➤ **Motive behind murder:-**

The accused Chepuri Narender is native of Suryapet and migrated to Hyderabad doing catering work and taking temporary shelter at Sundaraiah Park, Bagh Lingampally and having bad vices and consuming liquor. One year back he got friendship with Shastry Gopal (deceased) who is working under vegetable vendors by taking shelter and sleeping in the park.

Few days back some clashes raised in between accused and deceased in connection with keeping accused luggage/dress bag beside pan shop which is adjacent to Park premises. The deceased refused to keep the bag of accused. On that the accused bore grudge on the deceased and waiting to take opportunity for eliminate him.

On 17-03-2024 in the late night hours accused hatched plan to take revenge on Shastry Gopal (deceased), accused searched about deceased where he sleeping point and found the deceased sleeping opposite to Meenakshi Tiffin Centre, Baghlingampally then the accused with evil intention took a granite boulder and forcibly hit on the fore head of deceased for several times due to which the deceased died with pool of blood on the spot later the accused sped away from the spot.

Accused Chepuri Narender previously arrested in Cr.No. 276/2014 U/s. 379 IPC of Suryapet Town PS

➤ **ARREST:-**

The Task Force, Central Zone team verified the CCTV footages at all possible places, analyzed footages from surveillance cameras and also verified the modus operandi of accused persons and identified the accused .

Today i.e on 19-03-2024 acting on tip of Task Force Central Zone team apprehended accused Chepuri Narender and detected mysterious murder case of Chikkadapally PS.

The apprehended accused person handed over to SHO, Chikkadapally PS for further investigation.

### **TWO HELD FOR ILLEGAL POSSESSION OF DEER HORNS**

Acting on a tipoff the sleuths of Commissioner's Task Force, Central Zone team and Forest Range Officers, Hyderabad with joint operation laid a trap near Shankar Enclave, in the limits of Bowenpally PS apprehended (2) accused persons namely 1).Pittala Shoban Babu 2).Bonala Naga Chary who are indulging in illegally possession of Deer horns and searching buyers for selling to gain easy money illegally.

➤ **Details of apprehended accused persons:**

1. Pittala Shoban Babu S/o. P.Raju, age.25 yrs, Occ. Fruit seller R/o. Sikindlapur (village), Medak, Telangana.
2. Bonala Naga Chary S/o. late B.Janardan Chary, age. 40 yrs, Occ. Gold smith R/o. Bowenpally N/o. Dommata (village) , Warangal, Telangana.

➤ **Seized materials:-**

**1) Two Deer Horns**

➤ **Brief Facts:-**

Accused Pittala Shoban Babu is native of Sikindalapur village, Medak Dist and doing seasonal fruit business for his livelihood.

Accused Bonala Naga Chary is native of Dammata village, Warangal,Telangana. He is migrated to Hyderabad and doing goldsmith work at Bowenpally for his livelihood.

Few months back they both were came into contact and exchanged their phone numbers. One or two times Pittala Shoban Babu sold out birds meet to Naga chary.

Later the said Naga chary advised him to arrange Deer horns for selling Secunderabad market on higher price and sharing amount. On that Pittala Shoban Babu agreed his proposal.

Two days back Pittala Shoban Babu procured two deer horns from un known agent at Suraram for Rs. 2,000/- and handed over to Naga chary and trying to dispose on higher price to customers at Bowenpally

On 19-03-2024 the accused persons are searching buyers near Bowenpally Market for disposing Deer horns, meanwhile based on a tip off apprehended them and seized (02) Deer Horns from their possession.

**Buying, selling, keeping any wildlife articles or trophy is a violation of Wildlife Protection Act,1972 which is punishable offence.**

Apprehended two respondents 1)Pittala Shoban Babu, 2)Bonala Naga Chary along with seized two Deer horns handed over to Deputy Range officer, Forest Department West Range, Hyderabad for further investigation. Vide POR No.54/002/2023-24 of Forest Dept, Hyd.
