**NOTIFICATION**

In view of the announcement of General Elections to House of People (Lok Sabha), 2024 and in exercise of the powers vested in me under section 144 Cr.P.C. and as per the ECI (Election Commission of India) guidelines dated 08.06.2023, I Kothakota Sreenivasa Reddy, IPS Commissioner of Police, Hyderabad City, with a view to maintain public order and peace in the twin cities of Hyderabad and Secunderabad, hereby prohibit the:

- (A) Carrying of Licensed Arms till the completion of the election process,
- (B) Issue of fresh arms licenses till the completion of the election process,
- (C) Display of arms during a procession or any meeting in support of a candidate, under any circumstances during campaign period, in connection with the General Elections to HoP (Lok Sabha) scheduled to be held on 13-05-2024.

This order will come into force with immediate effect and remain in force till 06-06-2024 i.e., the completion of the election process.

The public are hereby informed that any person violating the above orders shall be liable for prosecution under the relevant legal provisions.

## **PRESS NOTE**

### **NABBED ROBBERY ACCUSED.**

The sleuths of Task Force, North Zone team along with staff of Kharkana PS on credible information apprehended one accused who committed Robberies.

➤ **Details of apprehended accused person :-**

- **Yenuka Ezra Sharon Vineeth** s/o.Y.Vinny Alston (late), age: 25 years, r/o. Old Bowenpally.

**Detected Case:-**

- 1) Cr.No.72/2024 U/sec.392 IPC of Kharkana PS.
- 2) Cr.No.173/2024 U/sec.392 IPC of Begumpet PS.

**SEIZED MATERIAL:-**

- 1) One Oppo A-16 Cell phone with SIM No. 7032053436.
- 2) One Pulser NS-200 Reg.No. TS-09 FS 6217.
- 3) Cash Rs.20,000/- (recovered cash Rs.12,000/- related to Kharkana PS & Rs.8,000/- related to Begumet PS.) **All.W.Rs.1,20,000/-**

**Brief Facts:-**

On 16-03-2024 around 11 p.m while the complainant B.Harish Kumarji was passing Bowenpally Market Yard on my TVS Jupiter Reg.No.TS 10 EV 2116 moving towards his house and when reached opposite New Kings Chinese Restaurant mean time the accused Yenuka Ezra Sharon Vineeth came on Pulser Motor cycle and stopped on the false pretext of rash driving, for which fell down and forcibly get transferred Rs.16,000/- through Google Pay.

**Modus Operandi:-**

The accused is residing in Vysya Bank Colony, Bowenpally, having previously been employed at Mindspace, Hi-tech City. However, due to his habit of alcohol consumption, he lost his job. Left without employment or income, he devised a plan to commit offenses in order to obtain easy money. Further he targeted solitary individuals driving in secluded areas. He initiates contact by feigning an accident, blaming the victim for a collision caused by their alleged reckless driving. Pretending to have sustained injuries from the supposed accident, he demands compensation from the victim. If they refuse to comply, he resorts to rob by either directly taking money from their pockets or coercing them to transfer funds through digital payment platforms like G-pay or phone pay.

Previously he had committed such type of robberies at Begumpet, Ranigunj, Bowenpally, Kharkana, Patny, Tadbun areas initially targeting small amounts to avoid drawing attention. However, since the sums involved are relatively insignificant, no one has come forward to report these incidents to Police. Thus, the accused continued this type of modus operandi, also increased robbed amount.

**Appeal to General Public:-**

- Beware of this type of false approaches by strangers.
- If anyone claim false accident and demands to give or transfer money, immediately approach local Police for Help.

**PRESS NOTE**  
**ARRESTED TWO ACCUSED PERSONS - INVOLVED IN TRADING FRAUD**

Cyber Crime Police, Hyderabad City arrested two accused persons namely 1) Tamanam Surendra, 2) D. Naresh Babu who were involved in Trading fraud case and providing the various Bank accounts to fraudsters, cheated the complainant in the guise of getting high returns on Trading.

**CASE FACTS:**

In the month of February, 2024 received complaint from victim resident of Hyderabad stating that accused person contacted him on whats app and added in whatsapp group Goldman (India) Sachs Securities Investment Management Ltd. after that fraudsters sent link to the complainant. Further complainant believed them clicked the link and downloaded the app and invested amount on online trading. He believed it to be genuine and registered in their website. Initially they suggested to investing smaller amount and returns profit. This manner they convinced him to do payment and at last they will give huge amount but they didn't return money and he lost total amount of **Rs. 57,37,536/-**. Cyber Crime police, Hyderabad registered a case in Cr. No. 398/2024 and investigated in to.

**MODUS OPERANDI OF ACCUSED:**

In this case the accused persons 1) Tamanam Surendra, 2) Damacharla Naresh Babu R/o Uppal, Hyderabad, who are an account holders were arrested on 20-03-2024, they met persons by name Raj Takur, R/o Delhi (Absconding), Jagadesh, R/o Nellore (Absconding) and Bharath Dasineni, R/o Nellore (Absconding) on Telegram App and supplied accounts to them on commission basis 1.5% per one lakh transaction they get 1500/-. Accused persons supplied 8 accounts to the fraudsters, within 3 months they transaction amount **5 Crore rupees**. As per NCRP data **83 cases registered** all over India against the accounts supplied by them.
