NABBED (03) DRUG PEDDLERS – SEIZED AMPHETAMINE WG ABOUT 16 GMS AND 03 CELL PHONES ALL WOTHR RS. 1,12,000/-

Today i.e., On 03-04-2024, on credible information the Commissioners Taskforce, East Zone Team along with Golconda Police, busted apprehended 03- persons who were in illegal possession of contraband drug i.e., Amphetamine drug and seized 16 grams of amphetamine drug and 03 cell phones, total Worth Rs.112,000/- from their possession.

Accused Details:-

- 1) Rekhapally Ravindra Babu @ Novel age: 26 yrs, N/o Dacheppally, Guntur.
- 2) Shaik Ismail @ Munna age: 21 yrs, R/o Manikonda N/o Ongole.
- 3) Ararthupudi Vijay, age: 21 yrs, R/o Manikonda, N/o Guntur.
- 4) Leela Venkateshwarlu R/o Guntur was found absconding.

Facts of the Case:-

The prime accused by name Rekhapally Ravindra Babu @ Novel was habituated in Consuming Ganja, over a period of time he addicted to Synthetic drug i.e Amphetamine, he noticed that there was huge demand in the market, so he hatched a plan to sell the drug in the market to gain huge profits. In this juncture he came into contact with one Leela Venkateshwarlu R/o Guntur and started procuring drug and selling in the open market and gaining huge profits, Leela Venkateshwarlu is also known to Shaik Ismail @ Munna is his Intermediate friend. So Munna also purchasing drug from Leela Venkateshwarlu and selling the same in the market. While so, the earnings of Munna is being observed by Ararthupudi Vijay and stated investing to procure durg. Accordingly Vijay made payment of Rs. 20,000/- as advance to Munna and procured 10 gms of Amphetamine drug for an amount of Rs. 6000/- per gram from Leela Venkateshwarlu and intend to sell and intend to sell it for Rs. 7000/-with the assistance of Rekhapally Ravindra Babu as he was induced in the market long time. Vijay and Munna with contraband drug proceeded to Golconda area near Zeeshan Hotel to deliver durg to Ravindra Babu, the trio were apprehended and seized contraband weight about 10 gms from Munna and 06 Gms from Rekhapally Ravindra Babu.

The above apprehended persons along with seized property were handed over to **SHO Golconda PS** for taking necessary action.
