BUSTED ILLEGAL SALE OF FAKE OXYTOCIN INJECTIONS - APPREHENDED (03) ACCUSED PERSONS

The sleuths of Task Force, South-West Zone team along with staff of Mangalhat PS on credible conducted a raid on **BANWARILAL SURESH KUMAR BANSAL** at Near Jet Cafe, Old Mallepally, Hyderabad who were selling **Fake Oxytocin Injections** illegally at exorbitant prices to needy customers, seized large quantity of **PHENOL I.P Injections** and apprehended (03) accused persons.

DETAILS OF ACCUSED:-

- 1) **Suresh Kumar Gupta** S/o Banwari Lal, Age:-70 yrs, Occ: Business, R/o Goshamahal, Hindi Nagar, Nampally, Hyderabad.
- 2) **Lala Babu Yadav @ Bunty** S/o Sri Rama Pati Rai, Age 35 years, Occ: Injection Preparator/Auto driver R/o Opposite Attapur police station, Near Sikh Chowni, Hyderabad.
- 3) **Abdul Haji** S/o late Abdul Aziz, Age 28 years, Occ: House Keeping R/o Nampally Govt hospital, Mallepally, Hyderabad.

SEIZED MATERIAL:-

- 1) Injection bottles – 100 (each 200 ML)
- 2) Acetic acid bottle -1 (2Litres)
- 3) PHENOL I.P (CARBOLIC ACID CRYSTAL I.P) (POISON)-12
- 4) Bucket -1
- 5) Mug-1
- 6) Mixing bowl -1

BRIEF FACTS OF THE CASE:

Oxytocin is indicated for milk let-down in cows and buffaloes by crating intra mammary pressure. Oxytocin injections are banned by the Government, to avoid its misuse in veterinary field by farmers and dairy owners to extract milk from Cattles.

The Prime accused by name Lala Babu Yadav@ Bunty hatched a plan to prepare Fake Oxytocin injections by diluting PHENOL I.P (CARBOLIC ACID CRYSTAL I.P) which is POISON with acetic acid and water. Generally PHENOL is not available for domestic purpose, as it is POISON. So, Abdul Haji, who works as House keeper used to supply PHENOL to main, accused Bunty. After Preparing Fake Oxytocin injection Bottles, Bunty used to supply these bottles to Suresh Kumar Gupta, who runs cattle feed Shop in Mangalhat and other dairies in and around Hyderabad city. This Suresh Kumar Gupta sells those bottles to farmers and dairy owners to extract milk from cattle. Believing their words, innocent farmers and dairy owners injecting these fake oxytocin injections to cattle to increase milk but it is dangerous to cattle and the persons who drink milk of that cattle's. The act of above respondents are very dangerous and harmful to human life.

In this regard a case has been registered against accused persons vide Cr.No:225 /2024 U/Sec U/s 420,336,273 IPC r/w 34 IPC and Sec 18© Drugs and Cosmotics Act of PS Mangalhat.

Previously also accused **Suresh Kumar Gupta** is previously involved similar type of case vide Cr.No.122/2018 U/s 273,420 IPC & Sec 18© of Drug and cosmetic Act 1940 of Habeeb Nagar PS

**NABBED ROBBER WHO COMMITTED ROBBERY OF GOLD EAR STUDS FROM
OLD AGED WOMEN- SEIZED EAR STUDS WG ABOUT 10 GMS, WORTH RS.
70,000/-**

Today i.e., on 29-04-2024, on credible information the Commissioners Task Force, East Zone Team along with OU Sity police, apprehended one robber by name **Orsu Giri** who committed robbery of ear studs from the old woman recovered one pair of ear studs wg. about 10 grams **w/Rs. 70,000/-** from his possession.

Accused Details:

Orsu Giri, age: 38 yrs, Occ: Labour, R/o Maniskeshwar Nagar, OU Sity, Hyderabad.

Seized Property:

One Pair Ear Studs Wg. About 10 Grams W/Rs. 70,000/-

Facts of the Case:-

The accused is a resident of the Vaddera Basti, Manikeshwar Nagar, Hyderabad and eking livelihood by doing labour works. He was addicted to consuming Toddy, he used to visit Toddy Compound at Lalapet regularly. Likewise on 27-04-2024 in the afternoon he went to Lalapet Toddy Compound and consuming Toddy where he met victim woman aged about 65 yrs, belonging to Lalapet who also came to consume the toddy, meanwhile, he started conversation with her and instigated to proceed Adikmet Toddy Compound to get good Quality of Toddy, Believing him, the old lady along with Giri proceeded towards Adikmet by boarding RTC Bus at Lalapet and they collectively deborded at Manikehwar Nagar Kaman and proceeded towards Adikmet Fly over by walk, as soon they reached Sports Authority Cycling Velodrome main gate which seems to isolated area, taking due advantage the accused forcefully Robbed ear studs where the victim succumbed ear injuries, thereafter the accused spontaneously sped away from the offence place. The victim was found lying on the foot path, she was noticed by one pedestrian and got enquired about the incident and the same was informed to OU Sity Police upon a case in **Cr.No 204/2024, U/s 392 IPC of PS OU Sity** and took up the investigation. While the investigation in under process, on 29-04-2024 the Commissioners Task force East Zone Team along with OU Sity Police nabbed the accused at Manikeswari Nagar while he is intend to dispose ear studs. Previously the accused was involved in **Cr. No: 638/2012, U/s 324 IPC of PS Alwal.**

The apprehended accused person along with seized property were handed over to **SHO OU Sity PS** for taking necessary action.

The above arrest was made under the supervision of Sri. **Ande Srinivasa Rao**, Addl. Dy. Commissioner of Police, Commissioners Taskforce, Hyderabad, **A. Nagarjuna**, Inspector of Police, East Zone Taskforce, **P. Ananth Chary**, **S. Karunakar Reddy**, and **P.
